**Dear Premier** 

Thank you for your letter dated 26 November 2021, written on your behalf by Mr Jim Murphy, Chief of Staff, in reply to my letter of 19 October 2021.

Your letter does not address my letter's core concerns and ignores its detail and fundamental questions. My letter was written on behalf of the many Queenslanders whose interests you are trampling.

Please note the data characterising the COVID-19 virus on pages 9 to 13 of **Attachment 1** to my letter of 19 October, which I <u>attach</u> for ease of reference.

Please also note the data and facts on the COVID-19 injections that you are coercing Queenslanders into having, injections that are the basis of the community division you intend to mandate from 17 December. This data is on pages 16 to 20 of **Attachment 2** to my letter, which I <u>attach</u> for ease of reference.

You and your government are mandating injections from foreign manufacturers that have not been fully tested in Australia and have only been partially tested overseas. They are essentially unproven in the long term and Federal Health Minister Greg Hunt has said, quote: "The world is engaged in the largest clinical vaccination trial".

Queenslanders are rightfully concerned.

You are effectively forcing people to be injected with an inadequately tested, unproven injection. Why are you doing this? Why are you ignoring freedom of choice?

Pfizer and Moderna injections use Messenger RNA that has never before been used on humans.

AstraZeneca injections use monkey adenovirus DNA that has been used only once before, for Ebola.

Both types of injections turn the human body into a spike-protein fragment factory, producing trillions of fragments that circulate through the human body to spur the body's immune system to recognise and fight the virus. This same spike protein is a pathogen, an agent that can cause disease.

The Pfizer injections have the following concerning characteristics:

- Duration of efficacy is unknown although recent studies show efficacy plummets within months.
- Data for use in the high risk and frail elderly over 85 years of age is limited.
- Safety and efficacy in children younger than 12 years is not yet established.
- Laboratory test results are lacking, no full datasets are available, and data is mostly reported by media release only.

- No interaction studies have been reported by Pfizer on interactions with other medicines.
- Associated use with other vaccines has not been studied.
- Pregnant women have become part of the experiment.
- It is unknown whether mRNA is excreted in human milk.
- The impact on fertility in males and females is unknown.
- The impact on next generations is unknown.
- · Genotoxicity is unknown. No studies on mutagenicity and mutations have been completed.
- Carcinogenicity is unknown and no studies have been done.
- There is no data on the long-term effects of the vaccines.

Astra-Zeneca injections have similar characteristics and deficiencies.

The injections you are coercing Queenslanders into taking do not give complete immunity from getting COVID-19, or from passing it on to others, or dying from it.

The frightening growing number of serious adverse reactions and deaths here and overseas show unacceptably high risk to those injected in the short-term and unquantifiable risk for the long-term. The Australian figures in this area are tainted deliberately by your government and downplayed. Why?

Your government has blood on its hands and you as the Premier of Queensland, are responsible. The next casualty of your mandate will be jobs and businesses as segregation impacts profitability.

Bankruptcies, unemployment, failed businesses and suicides are the direct result of your policies and failure as a leader.

Rapidly growing numbers of large protests across our state, councils refusing to enforce your division of society and frequent energised community meetings show that the people are now very angry with your threat to divide Queensland and to withdraw our fundamental human rights and freedoms.

People's anger is due to oppressive and needless hardship that your government imposes on innocent and hardworking Queenslanders. Your government's reckless actions contradict the data and often the science and are destroying personal, commercial, professional and community relationships and lives.

Your 17 December mandate will negatively impact our health and education, our lifestyle, our jobs and businesses. It will be unnecessarily divisive and drive a wedge between good citizens of Queensland based on their vaccination status. It will be discriminatory and stir up more anger in the community.

I request a meeting with you to present and discuss the facts that are increasingly apparent to the people of our state.
